

**\*Terms and Conditions:** The competition commences at **9am AEDT Monday, 2 March 2020** and closes at **midnight AEST Monday, 31 August 2020**.

**Method of entry:**

There are three (3x) individual challenges that entrants can participate in, with one (1x) prize rewarded for each challenge.
